



# What is Blockchain Technology?


Blockchain is an advanced mechanism for databases that allows transparent information sharing within a network. The database is stored in blocks linked together in a chain.

• The data is temporally consistent because the chain cannot be deleted or modified without consensus from the network. As a result, blockchain technology can be used to create an immutable or unchangeable ledger to track requests, payments, accounts, and other transactions. The system includes built-in mechanisms that prevent unauthorized transaction entries.

# **About VeneraChain**

- VeneraChain is a blockchain project aimed at addressing current challenges within the blockchain, with a particular focus on privacy, scalability, and security. VeneraChain offers a range of features, including a private first-layer blockchain network, a unique financial aggregation system, decentralized stocks, and a referral program using a League-style staged approach. The technical structure covers the PBFT consensus mechanism, smart contract management, data encryption, and storage.
- The areas that must be considered include potential adoption challenges in the competitive market, the importance of education and awareness to attract users and developers, the need for continuous security measures, and the significance of community involvement in successful management.



# **Investing in the VeneraChain project through the ROIC platform.**

When it comes to your investment, is divided into two main parts:



Part One

You will be staking your VCH token, where you can specify the staking period based on your personal preferences.

## Part Two

You will receive stakes in decentralized stocks, providing you with active participation in the system and an opportunity to benefit from market developments, leading to sustainable returns and profits.







# What are the gains and profits achieved by investors in the VeneraChain project through the ROIC platform?

• The key benefits that incentivize investors to purchase VCH and stake within the ROIC platform include:

#### **Earnings from Stock Fees**

Completing the VeneraChain project provides the opportunity for ongoing profits from fees by simply holding the stock.

#### **Auto Re-stake**

The platform allows investors to increase staked tokens and earn additional weekly profits for an additional period of up to 4 years even after withdrawing tokens from staking.



#### **Weekly Reward**

Weekly rewards that may reach over 100% annually.

#### **Price Differentials**

Price differentials exceed 5 times the current stage after the public sale trading phase.

#### Increase in Stock Value

## **The First Incentive**

# **Weekly Reward**

Anyone staking VCH within the ROIC platform will receive a weekly return, potentially reaching over 100% annually.

The interest value varies based on the quantity of staked VCH and depends on the staking factor K.

The size of the "Reward" depends on the duration of staking and the volume of tokens held by the participant.

## **How are Rewards Calculated?**

All funds used to purchase VCH by all investors within the ROIC platform go to the centralized wallet of the ROIC platform. Subsequently, they are converted into trading pairs within the platform to benefit from Swap operations, Fees, LP (Liquidity Provider) rewards, and then initiate the Yield Farming process.

The obtained returns are divided among all owners of VCH within the ROIC platform.

Weekly rewards = Staked token amount × K factor.

The yield may reach up to 100% of annual profits.

# Example

The weekly rewards for an individual who owns 10,000 staked VCH with a K value of 0.001 will be calculated as follows: 0.001 × 10,000 VCH = 10 VCH.



To obtain the value of K

The weekly commission amount due for an individual = The quantity of stacked VCH in the person's portfolio within the platform multiplied by the K factor.

# **Price Discrepancies**

After the staking period, the participant will benefit from the token's value appreciation in addition to an increased return on investment (interest).

The current stage is called the Seed Stage or Initial Stage, where VCH will be sold at a value of \$0.03. The suggested currency price at the beginning of trading may reach \$0.15, \$0.2, or more

An investor purchasing in the Seed Stage will see their capital multiply several





# **Staking Bonus within the ROIC Platform**

- The staking bonus depends on the staking period of the VCH token within the ROIC platform.
- If the token is staked for 4 years, the staking bonus can reach a profit of 20%.


